**FAFSA-** Complete the FAFSA at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) to see if you qualify for any federal and/or state grants (you could qualify for up to \$4,098 per semester in FREE money).



**Work Ready KY Scholarship-** Not eligible for grants? No problem! Apply for the Work Ready KY scholarship at [www.kheaa.com](http://www.kheaa.com). This award will pay tuition and up to \$400 in fees each academic year for up to 4 semesters. **\*\*Note:** your major must fall into one of these categories for this award:

- Healthcare
- Advanced Manufacturing
- Transportation/Logistics
- Business services/IT
- Construction/Trades
